Grosvenor rd/ Hillhead rd	Resident.	Used to be a fence at the end of pedestrianised Grosvenor Rd but has been taken out. Risk of children running/cycling straight out into main rd.	
Chapel Park	Resident. Others agreed.	Confusion over 20mph zones. Signs on road still say 30 but signs on posts say 20. Scheme hasn't stopped speeding: reduction has only been 1mph. Can't drive safely at 20 because no-one else is.	Would it be possible to get the mobile speed camera located on Greenway? (suggested by Cllr Hobson)
Area around the Tute.	Resident. Others agreed.	Trees beside building need thinning out. View of building and play area is obscured- increases ASB/crime risk. Hedgerows around site also v. overgrown. Area has had ASB problems already.	Cllr Donnelly has spoken to Tute about it – some work planned? (need to check to confirm)
Hillheads Pub.	Discussion between resident, officers and Cllr Hobson.	Some issues in past – not recent. Owner keen to make it more community/ family-friendly. Some concerns about this – promoting alcohol; going against health & wellbeing agenda; noise etc.	Pub will be there either way: better to work with owner to make it a community asset. Resident & Cllr Hobson discussed talking to owner about arranging 'forum' in the pub & inviting residents, councillors, officers and other agencies to discuss.
Wheatfield Rd/ Stamfordham Rd	Resident who waited at Beaumont Tce/West Ave for the Walkabout to pass by to 'thank the council for quick response last time'.	Black binbags full of food waste have been dumped here at least twice. Were removed quickly the first time but are back now.	NRM was part of this conversation and has followed up on it.

Kids knock them down; they're not visible in snow and cause damage to cars; some drivers drive faster because of them, using them like a slalom.	Resident felt speed bumps would work better.
Old Matchbox site	Residents	Parking pressures around local school	Would it be possible to have a car park to accommodate parents parking?
Garages around North Ave and back of West Ave	Resident	Kids hanging around causing concern to houses adjacent	
Field behind North Ave	Resident	Residents in Woburn Way, Rowedge Walk and West Ave backing onto this area have concerns about it esp since gate was removed. Scrap metal collectors accessing site are one concern.	Residents would like to take on management of field. If council would re-instate gate at West Ave, residents would like trees taking out, they would re-plant trees and plant bulbs etc.
Linhope Rd.	Residents	Cars parked on road, all the way up to the roundabout on West Ave	New car park on tennis site may help with this – although timescale for this is not imminent? Needs double yellow lines on one side at school picking up/dropping off times.
Notice board at left side of cut entrance, Roachburn Road	Andrew Lewis	Noticeboard needs replacing	To be replaced.
Behind Roachburn Road	Residents	Overgrown bushes etc – safety and crime/fear of crime issue.	Community Payback will start cutting back bushes (not trees) on 22/09/13. Work will be ongoing until bushes cut back safely for residents and users of pathway.

Reservoir	Sgt Grant Urquhart	ASB issues	This is being monitored by police.
Cowndon Rd (back lane entrance of Vets Practice) at Downend Rd shops	Resident	Difficult for mobility scooters, wheelchairs to cross safely. It is a busy road that bends around and currently users have to cross over and then cross back. (Opposite Hillheads Pub)	Dropped kerb needed.
Downend Rd shops	Shop owner	Alley used to be gated but gates have been removed. Concern about easy access to rear of shops for vandalism/burglary.	This is a private road owned by the landlord of the shops. Shop owners have raised concern with them.
Downend Rd shops	Shop owner	Concern about dog fouling outside shops.	Shop owner wanted warning signs putting up. Shopping parade includes vet and dog grooming business. Do they take responsibility – hand out bags, raise awareness etc?
Whole ward	Resident	<u>Suggestion for future approach/ format:</u> Split ward into 4 sections, hold pop-up meeting/ walkabout in one section per month, on a regular schedule. Should not replace formal meetings completely but might reduce need and deal with some issues more effectively.	Worth pursuing this? <u>Pros:</u> suggested by community member not councillors or officers; more localised focus and regularity - easier to publicise and engage; local collaboration/ involvement rather than expecting that the council will deal with issues <u>Cons:</u> buy-in from all currently involved may be a challenge; cost/ resources involved in doing this as an add-on to WC meetings....
